

Electrical and Electronic Equipment Regulation Processor, Hauler, Refurbisher Registration Form

This form is to be completed by processors, haulers or refurbishers of information technology, telecommunications and audio visual equipment (ITT/AV) who are required to register with the Authority under Section 22 of the <u>Electrical and Electronic Equipment (EEE) Regulation</u>. The deadline to register is November 30, 2020.

Note: only EEE refurbishers that refurbished 10 tonnes or more of ITT/AV equipment in 2019 are required to register.

Definitions:

An EEE <u>processor</u> is a person who processes, for the purpose of resource recovery, EEE used by a consumer in Ontario.

An EEE <u>hauler</u> is a person who arranges for the transport of EEE that is used by a consumer in Ontario and is destined for processing, reuse, refurbishing or disposal, but does not include a person who arranges for the transport of EEE initially generated by that person.

An EEE <u>refurbisher</u> is a person who prepares or refurbishes, for the purpose of reuse, EEE used by a consumer in Ontario.

Information technology, telecommunications and audio visual equipment (ITT/AV) means EEE, of which the primary purpose is collecting, storing, processing, presenting or communicating information, including sounds and images, recording or reproducing sounds and images, including but not limited to the examples set out in Section 1 of Schedule 1 of the EEE Regulation, but does not include equipment or products that fall into the category of lighting.
